#### **Process of Electing Councillor from Faenol Ward**

The Clerk explained that a vacancy notice had now been advertised on the Council's Website and would remain there until 28th June. Should a written request for an election be received from 10 of the electorate, then an election would have to be held. If this does not happen, the Council have the right to advertise their right to Co-opt and to invite names to be put forward

Cllr D Jones Morris was not present this evening to offer any comments on the notice-board but has sent an email expressing his dissatisfaction with the parking situation and speeding in the area.
